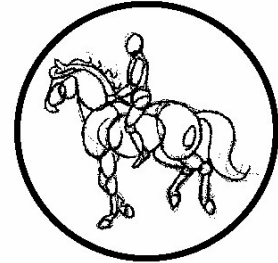

**Cost for one full week of camp (Mon-Fri) is \$425.00.** *Non-refundable, except in case of a documented medical emergency prior to camp date, that would affect attendance.*

A \$100.00 deposit is required to hold your space. Payment is by check, cash, or Paypal. Full payment due prior to start of camp. Returning campers and early birds (paying in full by April 1st) receive a \$50 discount. Sibling and “bring a buddy” discounts are also offered.

Participants will need the following dress and equipment: *(request discount coupon to tack store)* Comfortable jeans or riding breeches, paddock boots or hard-soled shoes with a heel, gym tights or leggings, short sleeved or t-shirt, light jacket, socks and sneakers. No shorts or sandals! Hair ties, sunscreen, snack, water bottle, and lunch . Approved riding helmets are required; you may purchase, or rent one of ours for \$10 per day.

**If demand warrants, certain camp weeks will be set aside for very young riders from 5-7 years of age. Please check with the administrator regarding age and camp level placement for your child.**

***Service Agreement:***
